This statement covers the [jobteaser.com](https://www.jobteaser.com) online platform and the JobTeaser Career Center.

JobTeaser endeavours to meet the standards expressed by The Directive 2016/2102, which was transposed into English law by the Public Sector Bodies (Websites and Mobile Applications) Regulations 2018, coming into force on 23 September 2018 (the “Regulations”).

2020 Digital Accessibility Strategy
